### HISTORY

The Institute of Shopping Centre Management (ISCM) was founded in 2002 by a group of local professionals in real estate who have extensive experience in managing shopping centres and malls in Hong Kong.

### OUR AIMS

The Institute is a learned and professional society with aims as representative of the field of shopping centre management and to standardize and elevate professional profile of the industry.

The Institute will liaise with various professional bodies, organizations, associations, governmental bodies and administrative officials both locally in Hong Kong and internationally in order to cultivate and maintain a platform for the exchange of best practices in the art and science of shopping centre management in the Asia Pacific Region.

### MEMBERSHIP

Membership is open to any individual persons or corporation, in any nation, currently who is a practitioner in shopping centre management or is a student who is enrolled in a course of professional study in the same.

Membership of the Institute is categorized into following grades:

1. Honourable Member (Hon.ISCM);
2. Fellow Member (FISCM);
3. Full Member (MISCM);
4. Associate Member (AISCM); and
5. Student Member.

The application shall be completed in full and must be accompanied by:-

1. Copies of Certificates of membership of other professional institutions;
2. Copies of Certificates relating to academic qualifications;
3. Employer's letter certifying the positions and job natures; and
4. A cheque in favour of 'Institute of Shopping Centre Management Limited' in amount of the annual fee of the applied grade of membership.

### MEMBERSHIP ELIGIBILITY

#### HONOURABLE MEMBER (Hon.ISCM)

To be recruited by invitation or nomination by the Board. A Honourable member shall be a member who, in the opinion of the Committee, has made a considerable contribution to the sphere of shopping centre management generally and to the aims of the Institute.

#### FELLOW MEMBER (FISCM)

- All professionals with 10 years' post-professional qualification working experience in the field of shopping centre and could be recruited by invitation or nomination by the Membership Committee;
- By upgrading application for those members with 5 years post-professional qualification working experience in the field of shopping centre management by application from full members.
- Invitation or nomination by 3 Fellow Members or Board Members is necessary.

#### FULL MEMBER (MISCM)

- All recognized course graduates as approved by the Board with at least 3 years' proven working experience in the field of shopping centre management;
- All professionals who have taken any recognized program / course at least at diploma or degree level with at managerial level;
- 10 years' experience at managerial level in shopping centre field or relevant industry endorsed by the Membership Committee.

#### ASSOCIATE MEMBER (AISCM)

- All recognized course graduates;
- Any person who has a minimum of 2 years' working experience in the field of shopping centre management but did not take any recognized courses;
- Final endorsement by the membership committee is required.

#### STUDENT MEMBER

- Any registered student who is currently undertaking or eligible to undertake relevant courses i.e. shopping centre management, property management, surveying recognized by the ISCM.

#### Overall Remarks:

Membership approval is subjected to final decision of the Membership Committee.
